



CITB NI BUILT ENVIRONMENT STUDENT BURSARY AWARD

TERMS AND CONDITIONS

- 1. The bursary application process is open from **Tuesday**, **13 August 2024** to full-time students, who are commencing their first year in a third level Built Environment related qualification (Level 4 or above) with a Northern Ireland training provider only.
- 2. Higher Level Apprenticeships in the Built Environment are exempt as these are already funded by the Department for Economy.
- 3. Applications will not be considered from applicants who have previously commenced or completed any other third level qualification at level 4 or above.
- 4. Applicants must be a resident of Northern Ireland.
- 5. Each applicant must have achieved **one** of the construction qualifications listed on the appendix attached to these terms and conditions as a pre-requisite to be able to apply and evidence of achievement **must** be submitted along with the application.
- 6. Only one application is permitted per student and must be submitted on the bursary application form and submitted by the closing date of **Friday**, **18 October 2024**. Applications received after the closing date will not be considered.
- 7. Applications that meet the bursary application criteria will be entered into a draw for random selection. Twelve winners will be chosen, and the draw will be performed by a random computer process of applications received in accordance with these Terms and Conditions. The random selection process is final, and no further communication will be entered into.
- 8. Each bursary award is £1,000 and will be paid to the successful applicants by cheque. There is no alternative award.
- Applicants will be advised they have been successful after the closing date of 18
 October 2023 and no later than 31 October 2023. The successful applicant will be
 notified by email.
- 10. Each successful bursary applicant will have 28 days from the date they achieve their first-year results to claim their bursary. If a successful bursary applicant does not supply relevant evidence of successful completion of their first year by then their prize will be forfeited and CITB NI shall be entitled to select another bursary applicant in accordance with the process described above (and that bursary applicant will have to submit their evidence within 28 days or else they will also forfeit their bursary).
- 11. If a successful bursary applicant rejects their bursary or the entry is invalid or in breach of these Terms and Conditions, the successful applicant's bursary will be forfeited and CITB NI shall be entitled to select another bursary applicant.
- 12. In accordance with GDPR CITB NI shall only use the data provided for the administration of the Student Bursary Award.





- 13. The information supplied, name, address, telephone, and email are only for the purposes of the Student Bursary Award and will not be used for any other purpose. All personal and contact information will be deleted once the Student Bursary Award is completed each year.
- 14. Bursary recipients may be required to participate in publicity arising from the competition and by submitting a bursary application you agree and provide consent to take part in such publicity. Such activity could be, but is not limited to, promotional pictures, press releases and case studies.
- 15. Application for the bursary signifies acceptance of these terms and conditions. CITB NI reserve the right to withhold, change or cancel any award in the event of non-compliance with these rules and reserve the right at their discretion to amend the application rules at any time and change the terms and conditions accordingly.
